-DIRECTOR'S MESSAGE



By participating in pro bono work, SMU Law students are able to give back to the community at an early stage of their legal training. Equally important is that they learn important skills which will help them become better lawyers in the future. Mohamed Khairulnizam (Khai), winner of the Pro Bono Hero Award (JD), says that pro bono work has helped him to understand the challenges faced by different groups in our society and deepened his empathy and compassion towards others; and Gini Wong, winner of the Pro Bono Hero Award (LLB), tells me that taking part in pro bono projects has affirmed her conviction and passion to serve the community with her knowledge and skills.

In addition to the weekly free legal clinic held at SMU which provides assistance to around 200 applicants annually, SMU Law students gave more than 30 legal awareness talks, assisted volunteer lawyers in certifying over 100 Lasting Powers of Attorney, supported around 20 families to apply for deputyship orders via the Family Justice Courts' Integrated Family Application Management System (iFAMS), helped lawyers in about 20 pro bono criminal or family cases, and worked on about 25 Wills for Special Needs Trust Company beneficiaries this year.

In July 2023, the SMU Pro Bono Centre organised a 2-week overseas trip to Vientiane, Laos, to assist a law-related NGO to enhance legal education and access to justice. This is the very first overseas community service trip for SMU students devoted to legal work. We look forward to more opportunities where students can serve communities in Singapore and beyond.

The strong pro bono culture in SMU is exemplified by the number of pro bono hours served. As a graduating cohort, the Class of 2023 collectively contributed 7,762 pro bono hours, which averages 42 pro bono hours per student, more than double the 20 hours that is required of them. Furthermore, 10 JD and 12 LLB students went the extra mile to contribute over 50 and 80 pro bono hours respectively!

I am also proud that all four of the volunteer lawyers to be recognised at the Volunteer Appreciation Dinner 2023 are our SMU Yong Pung How School of Law alumni:

- Alvin Ong is conferred the Spirit of Pro Bono Champion Award for having participated the most number of times in the PBC Legal Clinic this year;
- Matthew Teo, Christian Teo and Jasper Chan are conferred the Spirit of Pro Bono Bronze Award for having volunteered at the PBC Legal Clinic for at least five years.

Finally, I wish to express my heartfelt thanks to all our valued community partners and volunteer lawyers (SMU and non-SMU alumni) for their generous support. They have provided SMU Law students with invaluable opportunities to hone their legal skills and nurture a strong sense of social responsibility.






Profile of the applicants








Legal issues presented at the SMU Pro Bono Centre Legal Clinic
