

FAQ: Restrictions on Individuals

Q: What does a “specified school” mean?

A: This means:

- a) A school in receipt of grant-in-aid under the Education (Grant-in-Aid) Regulations
- b) A school specified in paragraph 2 of the Schedule to the Compulsory Education (Exemption) Order:
 - i. Madrasah Alsagoff Al-Arabiah
 - ii. Madrasah Al-Arabiah Al-Islamiah
 - iii. Madrasah Irsyad Zuhri Al-Islamiah
 - iv. Madrasah Aljunied Al-Islamiah
 - v. Madrasah Al-Ma’arif Al-Islamiah
 - vi. Madrasah Wak Tanjong Al-Islamiah
- c) A school specified in Part II of the Schedule to the Education Endowment and Savings Schemes (Edusave Pupils Fund) Regulations:
 - i. AWWA School (formerly known as Asian Women’s Welfare Association Special School)
 - ii. Canossian School (formerly known as Canossian School for the Hearing Impaired)
 - iii. Chaoyang School (formerly known as Chao Yang Special School)
 - iv. Eden School (formerly known as Singapore Autism School)
 - v. Fernvale Gardens School (formerly known as Yio Chu Kang Gardens School)
 - vi. Grace Orchard School
 - vii. Katong School (formerly known as Katong Special School)

Q: What do essential services refer to?

A: They refer to:

- a) any provision of goods or services by the Government or any public body in the exercise of its public functions; or
- b) any provision of goods or services specified on this website:

Q: What does “essential service provider” mean?

A: It means:

- a) the Government or any public body;
- b) a person who provides any essential service; or
- c) a person who is given permission by the Ministry of Trade and Industry to provide certain goods or services, for the period or from the date stated in the permit.

Q: What does “essential service worker” mean?

A: This means:

- a) an employee of the essential service provider; and
- b) a contractor, a subcontractor or an employee of a contractor or subcontractor of the essential service provider, where the contractor, subcontractor or employee (as the case may be) works under the direction of the essential service provider as to the manner in which the work is carried out.
